### SCHOOL STARTS SOON!



**Tips for Motorists:** Be alert and slow down when driving in neighborhoods with school zones. Watch for children walking, playing or assembling near bus stops. Children arriving late for the bus may dart into the street without looking for traffic. Obey the "flashing signal light system" used for school buses. **Yellow flashing lights** indicate the bus is preparing to stop to load

or unload children. Motorists should slow down and prepare to stop their vehicles.

**Red flashing lights and extended stop arms** indicate the bus has stopped and children are getting on or off. Motorists must stop their cars and wait until the red lights stop flashing, the extended stoparm is withdrawn, and the bus begins moving before they can start driving again.

# The 2020 JOHN T. HANNA AWARDS: Recognizing Traffic Safety Excellence in Hampton Roads

In 1991, Concerned Citizens Advocating Traffic Safety (the previous name of Drive Safe HR) instituted the JOHN T. HANNA AWARDS. ### **AWARD CATEGORIES**

**Lifetime Safety Achievement Award:** Presented for lifetime achievement in the area of transportation safety.

**Employer Safety:** Presented for employers who have taken the extra initiative to promote traffic safety and encourage their employees to practice safe driving behaviors.

Martin H. Schlosser Award for Traffic Safety Activism: Presented for outstanding efforts in educating citizens and changing attitudes and behavior regarding transportation safety.

**Roadway Innovations:** Presented for Individuals and/or organizations that show exemplary achievement in the design and/or implementation of highway engineering techniques, technology, and innovative approaches.

**Impaired Driving Prevention:** Presented for encouraging the prevention of drunk, drugged, drowsy, and/or drugged driving.

**Law Enforcement Initiatives:** Presented to a law enforcement department or individual who has shown extra initiative above and beyond the normal duties to promote and encourage traffic safety within their community.

**Legal:** Presented to attorneys, judges, or legislators who have actively supported safety issues thus strengthening existing laws and creating new laws that impact communities to help improve or reduce highway safety-related behaviors.

**Messaging/Media:** Presented to individuals or organizations, including but not limited to media representatives or news outlets, that have created messaging, used an innovative outreach method, or have helped spread the word about traffic safety through reporting or programming.

**Occupant Protection:** Presented for promoting and encouraging the use of safety belts and/or child safety seats through creative and innovative programs and activities.

**Transportation Safety:** Presented for developing approaches in the public and/or private sector, encouraging, educating, and/or promoting traffic safety to improve safety for drivers and riders. (\*\*MODIFIED CATEGORY\*\*)

**Youth Traffic Safety:** Presented to persons or programs educating youth and spreading the message on the importance of youth traffic safety.

**Fire/Emergency Medical Services:** Presented for actions at crash scenes or for activities or efforts that have a broader impact on improving at-scene safety and/or survivability and injury reduction for victims. (\*\*NEWEST CATEGORY\*\*)

### Eligibility, Rules, and Notification:

Any individual, business, organization, or governmental agency in the Hampton Roads and Eastern Shore area, which promotes community traffic safety, i.e. sober driving, use of safety belts, bicycle or pedestrian safety, motorcycle safety, incident management, etc., is eligible for nomination. Show us how you incorporated COVID policies into your programming! 2019 JOHN T. HANNA AWARD winners are not eligible for 2020 nomination. Eligible activities, programs or materials are those that were initiated, completed, published, or produced in the period from October 1, 2019 to September 30, 2020. Entries must be received by November 20, 2020.

**FACT:** In 2019 alone, 126 people were killed and 635 people were injured in collisions at railroad crossings. From 2014-2019, there were 798 fatalities involving motor vehicles at railroad crossings.



### **COVID-19 IMPACTS ON HAMPTON ROADS**

<u>Covid Impacts On Hampton Roads</u>: HRTPO staff has been keeping track of regional travel levels during the COVID-19 pandemic. Check out this PDF with the most recent analysis of regional travel levels throughout the COVID-19 pandemic.

Hampton Roads COVID-19 Impact Planning Hub: The HRPDC will maintain this page to provide information, maps/data, and resources concerning the COVID-19 pandemic impact in the Hampton Roads region. The Hampton Roads Planning District Commission Planning Department built an online dashboard to track data at the local and regional level: the regional 7-day moving average of daily new cases, confirmed total cases, hospitalizations and deaths as well as cases per 10,000 population per locality, as well as rate of cases by zip code, race, gender and age. In addition to health data, certain transportation and economic data are updated weekly as it pertains to traffic volumes, vehicle miles traveled, and unemployment claims, which are three of the most immediately available indicators of the impact COVID-19 may be having on the regional economy.

### **DMV UPDATE**

While overall traffic deaths have decreased in Virginia recently due to the pandemic, more people are dying in unbelted crashes. When comparing data between Jan. 1 - June 30 in 2019 and 2020, unrestrained fatalities increased nearly 16% this year. ### SAFE, QUICK CLEARANCE OF TRAFFIC INCIDENTS TOOLKIT

The International Association of Chiefs of Police (IACP) and the National Highway Traffic Safety Administration (NHTSA) created the Safe, Quick Clearance of Traffic Incidents toolkit to provide law enforcement executives with information that demonstrates the importance of adopting practices that facilitate the safe, quick clearance of traffic incidents in order to increase responder and public safety; reduce traffic congestion and the risk of secondary crashes; and the overall quality of life in communities. <a href="https://www.theiacp.org/resources/safe-quick-clearance-of-traffic-incidents-toolkit">https://www.theiacp.org/resources/safe-quick-clearance-of-traffic-incidents-toolkit</a>

### FMCSA CORONAVIRUS (COVID-19) INFORMATION & RESOURCES

FMCSA gas extended the declaration of emergency. The extension of Emergency Declaration No. 2020-002 provides regulatory relief for commercial motor vehicle operations providing direct assistance in support of emergency relief efforts related to COVID-19 and is limited to transportation of (1) livestock and livestock feed; (2) medical supplies and equipment related to the testing, diagnosis and treatment of COVID-19; and (3) supplies and equipment necessary for community safety, sanitation, and prevention of community transmission of COVID-19 such as masks, gloves, hand sanitizer, soap and disinfectants. Direct assistance does not include routine commercial deliveries, including mixed loads with a nominal quantity of qualifying emergency relief added to obtain the benefits of this emergency declaration. FMCSA has concluded that there is no longer a need for emergency relief with respect to the other categories of supplies, equipment, and persons covered by the May 13 extension and expansion of Emergency Declaration No. 2020-002, and those categories are therefore no longer covered.

This notice extends the exemption through August 14, 2020, subject to the restrictions and limitations set forth in this Extension.

The guidance on the webpage is being adjusted accordingly, and specifically note that precursor items are not included for those items covered by this declaration.

### TEENAGER INVENTS A SOLUTION TO ELIMINATE BLIND SPOTS FOR CARS

A 14-year-old from West Grove, Pennsylvania, won a \$25,000 prize for creating a prototype designed to eliminate a car's blind spots. The A-pillar design in a car supports the windshield and provides protection in case of a crash. However, their size and angle also create blind spots, the area of the road not visible to drivers from their usual sitting position or rear-view and side mirrors. Gassler's project uses a webcam, projector, 3D printed adapter and retroreflective fabric to make a car's A-pillars invisible by displaying the image of the blind spot behind them onto the pillar.
