#### NO SMOKING IN VEHICLES WHEN MINORS ARE PRESENT

As of July 1st, 2020, it is unlawful for a person to smoke in a motor vehicle in Virginia, whether the vehicle is in motion or at rest, when a minor under the age of *fifteen* is present in the motor vehicle. A violation of this law is punishable by a civil penalty of \$100. (VA Code§ 46.2-810.1 0)

#### **NEW VIRGINIA LAW:**



Heads up Virginia drivers! Put your phones down while driving anywhere in the state of Virginia. **Starting on January 1, 2021**, law enforcement will issue tickets for this primary offense of observing driving holding their cellphone while driving. The first offense costs \$125. The second offense will cost \$250 or if the driver is observed violating the handheld phone ban while driving law in a work zone.

Be smart and put your phone down while driving. Distracted driving is dangerous and costly. Often underreported, distracted driving by cell phones has caused thousands of deaths across the country every year and costs billions of dollars to the economy. #### **TOWARDS ZERO DEATHS:**

Zero is NOT an impossible goal for Virginia drivers. However, it will take ALL of us to get there. TOGETHER, we can stop roadway fatalities in Virginia. Aggressive drivers typically tailgate and make frequent lane changes, whip in and out of lanes to try to advance ahead, and run red lights and speed. As speed gets higher, the risk of death, disfigurement, and serious injury during crashes increases.

According to the National Highway Traffic Safety Administration, (NHTSA), a crash on a road with a speed limit of 65 mph or greater is: More than twice as likely to result in death than a crash on a road with a speed

limit of 45 or 50 mph. Nearly five times as likely to result in death than a crash on a road with a speed limit of 40 mph or below. (https://tzdva.org)

When you see aggressive drivers on the roadways:

- Make every attempt to get out of their way.
- Put your pride aside and don't challenge them.
- Avoid eye contact and ignore gestures.
- Don't sink to their level; remain a safe, courteous driver.
- Report serious aggressive drivers to law enforcement after pulling over in a safe place; be prepared to provide a description of the vehicle, location, direction of travel, and license plate.

The Holiday Season is known for being merry and bright, but it's also known for being the deadliest season when it comes to impaired driving. Every holiday season, lives are lost due to drunk drivers.

## WHICH STATES HAVE THE MOST DRUNK DRIVING PROBLEMS? (Click Here)

Although drunk driving fatalities in the United States have been reduced by nearly 50% since the early 1980s, alcohol-impaired driving remains a serious problem on America's roadways. In 2018, 29% of total motor vehicle fatalities were a result of alcohol impairment, wherein an operator of a vehicle involved in the crash had a blood alcohol concentration of .08 or greater. The good news is that this is the lowest percentage of alcohol-related fatalities since the NHTSA began reporting alcohol data in 1982. However, the rate is much higher in some states compared to others.



#### **DMV UPDATE**



In the days leading up to the holidays, we all need to remind Virginians that buzzed driving is a serious, risky behavior that causes needless deaths. Last year before the holidays, from Nov. 30 to Dec. 15, 2019, there were 336 alcohol-related crashes, 215 injuries and seven deaths in the Commonwealth. You can help educate Virginians on the dangers of buzzed and drunk driving in the weeks leading up to the holidays from Nov. 30 to Dec. 15, 2020.

The National Highway Traffic Safety Administration has downloadable pre-holiday season messaging on its Traffic Safety Marketing <u>website</u>. Additionally, you can access the anti-drunk driving "Act Like It" social media toolkit <u>here</u> from highway safety partner WRAP. The toolkit has social media graphics sized for Facebook, Instagram and Twitter, and draft posts to remind Virginia drivers that if they're old enough to drink to Act Like It by not drinking and driving.

During these unprecedented times, it may seem that there are more cases of high rates of speed and unrestrained travelers on the road now than in the past, the observation is correct. From January 1, 2020 to September 10, 2020, data shows a 20% increase (226 to 272) in speed-related fatalities and a 22% increase (190 to 232) in unrestrained fatalities compared to the same time in 2019.

Speeding endangers everyone on the road, excessive speeding is occurring in every community. Excessive speed injures or kills pedestrians, bicyclists, operators of motor vehicles, as well as passengers in motor vehicles. In 2019, speed related crashes killed 349 people on Virginia roadways and there were 274 unrestrained fatalities. Of course, the best way to protect yourself and others in your vehicle during a crash is wearing your seat belt.

However, it will take all of us together, government entities, law enforcement entities, faith-based groups, civic groups, educational groups as well as each individual member of our respective communities to slow the tide of the problem with excessive speed and non-seat belt use. Speed limit and seat belt laws are put in place to protect all road users within our, community.

To help prevent speed and seat belt related fatalities, to ensure that motorists are obeying the speed limit and are buckling up, the VA Highway Safety Office (VA HSO) and Drive Safe Hampton Roads is asking partners and citizens to continue your efforts and help educate your local communities about the consequences of not obeying speed limits and not wearing a seat belt. In addition, there is a quick reference tool to list the partners' information that can be used to educate our communities as well.
