Eligibility, Rules, and Notification:

Any individual, business, organization, or governmental agency in the Hampton Roads and Eastern Shore area, which promotes community traffic safety, i.e. sober driving, use of safety belts, bicycle or pedestrian safety, motorcycle safety, incident management, etc., is eligible for nomination. 2021 JOHN T. HANNA AWARD winners are not eligible for 2022 nomination.

Eligible activities, programs or materials are those that were initiated, completed, published, or produced in the period from October 1, 2021 to September 30, 2022.

Entries must be received by November 18, 2022.

FACT:

Approximately one-third of all traffic crash fatalities in the United States involve drunk drivers (with BACs at or above .08). In 2020, there were 11,654 people killed in drunk-driving crashes.

FACT: In 2021, 60 teens between the ages of 15-19 died on the roads of the Commonwealth with 9 of those fatalities in Hampton Roads, according to the Department of Motor Vehicles (DMV). Lack of a seat belt accounted for 5 teen deaths in Hampton Roads out of the 33 unrestrained teen fatalities statewide.

DMV UPDATE

Virginia DMV along the Nation Highway Traffic Safety Administration (NHTSA) recognizes October as Pedestrian Safety Month. Responsibility for pedestrian safety begins with each individual. If a crystal ball could predict who, what, where or when the next victim would be involved in a pedestrian crash, it would be useful to eliminate such tragedy. Individuals cannot rely on a crystal ball, and distractions, such as those created by cell phones, increase the chance of becoming a victim of pedestrian crashes, injuries and fatalities.

The best practices, such as, to cross at crosswalks, look both ways before crossing a street, to walk against traffic when not on a sidewalk, and to wear bright/reflective colored clothing, are all applicable to individuals walking, biking and rolling. https://www.youtube.com/watch?v=ndTzbZjALTA

PEDESTRIAN SAFETY

FACT: From 2011 and 2020, there were 1.6 times more fatalities among pedestrians (183) than occupants of school buses (113) in school-bus-related crashes.

PREVENT ILLEGAL SCHOOL BUS PASSING AWARENESS CAMPAIGN OCTOBER 17-21, 2022 / NATIONAL SCHOOL BUS SAFETY WEEK



Statistically, school buses are the safest way to transport school children. Yet more injuries and fatalities occur outside of or near a school bus because a motorist has failed to obey the stop-arm warning or to follow local traffic laws.

Respect the "Danger Zone"

The school bus loading and unloading area is called the "Danger Zone." Specifically, this is any side of the bus where a child may not be seen by the bus driver and, therefore, is in the most danger. Let's work together to keep our children safe as they wait to ride the bus to and from school.

FACT: A total of 218 school-age children (18 and younger) died in school-bus-related crashes during that period, either as occupants of school buses or other vehicles, or on foot or bike. Of the 218 deaths, 85 were children who were walking.

OCTOBER IS NATIONAL PEDESTRIAN SAFETY MONTH



The personal, physical, and environmental benefits of walking can lead to healthier, quieter, cleaner, and safer streets. Walking can also improve local economies and enhance social and community engagement, which can lead to more vibrant, resilient, and livable spaces.

Unfortunately, in 2020 there were 6,516 pedestrians killed in the United States. That is 18 pedestrians a day and 125 pedestrians a week.

FACT:

On average, a pedestrian was killed every 81 minutes and injured every 10 minutes in traffic crashes in 2020.

URBAN TRAFFIC FATALITIES NOW EXCEED THOSE ON RURAL ROADS

According to research from the AAA Foundation for Traffic Safety, more people are now killed on the nation's city streets than on rural roads, with speed playing a critical factor.

The problem: Between 2010 and 2019, fatalities in urban areas surged 34%, while those in rural areas fell 10%. Urban fatalities surpassed those in rural areas in 2016; by 2019, 19,595 people were killed in urban locations compared to 16,340 in the countryside. The upward trend in urban crash projections will rise as populations and vehicle miles traveled in urban areas increase.

FLEET DRIVERS AVERAGE 4.5 CRASHES YEARLY

Fleets reported an average of 4.5 accidents per driver per year, with more than a third of those attributing fault to the driver. The top reason given for what motivates fleets to address safety concerns was to reduce fleet maintenance costs. 57% of those who currently use telematics/GPS tracking consider it very effective in helping to improve safety within their fleet. An additional 17% consider it extremely effective.

WHY IS SPEEDING SO DANGEROUS?

The higher the speed, the more deadly the crash, as speeding can reduce a driver's ability to negotiate curves or move around obstacles in the roadway. Speeding is illegal and endangers not only the lives of the occupants in the speeding vehicle, but all of the people on the road around them, including law enforcement officers. In the United States, driving over the speed limit or too fast for conditions is the factor cited most often by law enforcement officers when they investigate a fatal crash.

A driver needs at least 1 second to react. The faster you drive, the farther your car will continue to travel before it can stop. This means you're more likely to crash. And, the faster you drive, the greater the amount of mechanical (kinetic) energy that must be absorbed by the impact. This means you're more likely to be killed or seriously injured.

The U.S. Environmental Protection Agency reports that for most vehicles, gas mileage usually decreases rapidly at speeds above 50 mph. In general, each 5 mph you drive over 50 mph is like paying an additional 20 cents a gallon for gas.


